



You can combine the following communication services to shape your own specific solution:


- CS.EDI: EDI service

Unlimited EDI communication with CS.EDI.

Our CS.EDI service makes fully automatic electronic data exchange possible for a variety of company processes such as ordering and accounting, payment transaction or logistics. The service supports all common standard formats (such as EDIFACT, VDA, ODETTE, ANSI X.12, XML, CSV) and in-house formats.



As the central hub for conversion and messaging, CS.EDI supplies all the necessary interfaces, partner profiles and communication facilities.

Cost reduction:

Your most affordably priced communication channel based on your business partners' technical set-up is automatically selected for the transmission of your data in the corresponding protocol, i.e., AS2, X.400, Telebox, VPN, OFTP, FTP or SMTP.



Integrate small suppliers into your processes quickly and easily with CS.WebEDI.

Do business like retailers or car manufacturers do. Enable your suppliers who are not yet EDI-compatible to still communicate with your ERP system by allowing Mercoline to provide you and your business partners with its web-based CS.WebEDI portal solution. This solution enables you to further reduce your internal costs

for processing the broadest variety of procedures such as orders, delivery notes or invoices. The CS.WebEDI service is operated by Mercoline and used by numerous partners in the Mercoline communications network, keeping costs at a minimum for its individual users.



CS.WebEDI allows you to exchange messages with business partners who are not EDI-compatible.

The system requirements for your partners are minimal (internet access, browser).

The procedure:

- In the so-called turnaround process, you and your business partners exchange EDI-compatible messages such as orders (ORDERS), delivery notes (DESADV) or invoices (INVOIC).
- There is virtually no manual data entry, since this is done automatically from presets.
- Reminders ensure prompt notification regarding procedures that have not yet been processed (for instance, new orders).
- CS.WebEDI was developed on the basis of the GS1-Germany Web EDI recommendation.

Process optimization for Accounts Payable and Accounts Receivable.


Everyday practice shows that despite EDI and Web EDI, media disruptions are still prevalent today. With Mercoline's e-invoicing services, you can significantly increase your quota of electronically dispatched and received invoices. You can easily use more CS.Line modu-

lar services alongside CS.EDI and CS.WebEDI to create your own individual e-invoicing solution. No hardware and software investments are required and you benefit right off the bat from the verifiable effects.

Save with a qualified electronic signature.

In accordance with the German tax legislation (UStG), the German tax authorities also accept electronic invoices for input tax deduction. One example of how this can be done is that every EDI invoice is inscribed with a qualified electronic signature. The solution: CS.eSignature. Use CS.eSignature to avoid additional investments while relying on a highly productive complete solution and

Mercoline's services. Your invoices and credit notes are signed or verified by Mercoline on your behalf. Signature files and test protocols can be saved together with source documents, and communication with your business partners and trust centers is secured.



Electronic invoices or other documents can be legally signed and verified with CS.eSignature. No investment necessary: You use the existing infrastructure.

Invoice sender:

 As the sender, your invoices and credit notes are signed electronically. Delivery of the verifications from the originator to the business partner(s) is conducted in a manner that rules out the possibility of forgery. The EDI signature server reliably transmits a variety of formats (such as EDIFACT, VDA, PDF) in compliance with the European Parliament's Directive 1999/93/EC.

Invoice recipient:

As the recipient, signed invoices are verified and can be entered and archived in accounting and ERP systems without media disruptions.


The results of numerous customer projects demonstrate that conversion to the qualified electronic signature option yields savings of between one and four Euros per document.

Digitalize paper documents. Integrate them into your workflow.

Sometimes it can be difficult to persuade smaller business partners or partners with whom you don't do business on a regular basis of the benefits of EDI or Web-EDI. In such situations, Mercoline's full service CS.Scan facility takes care of the digitalization of paper documents like invoices that you receive. Precisely coordinated processes are decisive for the quality of the data. High-performance scanners automatically scan all documentation, while intelligent

OCR software takes care of data extraction, document recognition and classification. The result you receive as the customer, just like with classic EDI or Web-EDI, is the invoice data delivered directly into your ERP system in your in-house format. In the end, the digitized paper invoice is no different from other invoices and can then be fed into the invoice workflow.




CS.Scan also enables you to come to grips with paper documents. You define the target format and the level of data extraction. Mercoline supplies you with the data in your in-house system.

Manage non-electronically sent documents.

Actually, you're trying to avoid paper, but sometimes there's no choice but to print documents like invoices and send them out by mail. An internal process costs analysis will

show you that printing and handling costs are very high. And this is where Mercoline's CS.Print service comes in.



CS.Print gives you a high-performance printing infrastructure. You initiate printing processes directly from your in-house system.

Our service:

- You provide Mercoline with your printing files including recipient addresses in an agreed format such as PDF.
- During the printing process the system calculates the best postage rate. After enveloping, the system then affixes postage to the envelope.
- Printing of the documents is conducted with individual sorting using barcodes and data matrix codes such as zip codes/post codes.
- You profit directly from the bundled printing volume of all the partners in the communications network.

Outsourcing your electronic business processes not only saves you money, but also up to three days time compared to internal processes.

Legally compliant archiving. More security.

With CS.Archive Mercoline provides an audit-proof archiving of all electronic messages (e.g. invoices) and associated files (e.g. signature files). They utilize low-cost archiving infrastructure Mercoline and immediately meet the statutory requirements of § 14 UStG, AO, GDPdU.

With CS.Archive you save the investment in hardware and software to build a storage and archiving infrastructure. Mercoline takes over all tasks for you.

CS.Archive includes ...

- Automatic archiving of all data within the agreed Mercoline communications services throughout the EDI and signature processes
- Archiving in a logically dedicated customer archive system in secure server environment
- Archiving for the prescribed period, for example six or ten years
